ROBOTICS TEAM GRANTS WERE PROVIDED TO A NUMBER OF MIDDLE AND HIGH SCHOOLS IN ORDER TO FUND THE CREATION AND COMPETION FEES OF ROBOTICS TEAMS. THESE GRANTS SUPPORT EDUCATION THROUGH PROVIDING STUDENTS WITH OPPORTUNITIES TO APPLY S.T.E.M. LEARNING TO REAL LIFE SITUATIONS AND COMPETITIONS WITH OTHER SCHOOLS. MICHELIN GOLDEN APPLE TEACHER GRANTS PROVIDE GRANTS UP TO \$250 EACH TO TEACHERS TO FUND CLASSROOM NEEDS THAT WOULD NOT BE AVAILABLE OTHERWISE THAT ENHANCE CREATIVITY AND LEARNING. EXAMPLES OF PROJECTS FUNDED INCLUDED LITERACY THROUGH PROJECT BASED LEARNING, CLASS BOOK CLUBS, SPECIALIZED READING SPACE AND S.T.E.M. THROUGH PLAY. THE FOUNDATION AWARDED \$7,154 IN MICHELIN GOLDEN APPLE TEACHER GRANTS FOR FISCAL YEAR 2021.
